

Terms and Conditions

Q1 2026

1. Information on how to claim and the offer form part of these Terms and Conditions (“Terms and Conditions”). Participation in the Q1 2026 Save up to \$1000 on selected Victoria Freestanding Cookers (“The Offer”) is deemed acceptance of these Terms and Conditions. Claimants must comply with these Terms and Conditions.
2. The Promoter is Smeg Australia Pty Ltd ABN 33 146 901 082 (“Promoter” or “Smeg”).
3. The Promotion **commences at 9:00am (AEST) on 29 January 2026 and closes at 11:59pm (AEST) on 25th February 2026 (“Promotional Period”)**. The Promotional Period may be extended at the sole discretion of the Promoter.
4. The Offer is only valid for purchases made in Australia.
5. The Offer is provided as a dollars off the recommended retail price of Participating Products, applied at the point of purchase in-store or online via a Participating Retail Store. Redemption is not required.
6. The Offer is: Save up to \$1000 on selected Victoria Freestanding Cookers (“Participating Products”), as listed in Appendix A.
7. Any promotional quote or pricing issued by Smeg Australia Pty Ltd or a Participating Retail Store in relation to this Promotion is valid for 7 days from the date of issue, unless otherwise stated in writing by Smeg. After this period, the Promoter reserves the right to amend or withdraw quoted pricing at its sole discretion. Availability and pricing are subject to change based on stock levels and retailer participation.
8. For the purposes of these Terms and Conditions:
 - a. “Participating Retail Store” means any one of the Australian retail stores that is authorised by Smeg to sell Participating Products and has been invited by the Promoter to participate in the Promotion. Please contact the store prior to purchase to confirm eligibility.
 - b. “Participating Product” means any of the Smeg products listed by model name and number in Appendix A that are supplied by Smeg in Australia and sold by a Participating Retail Store.
 - c. All colours are applicable to the promotion.
9. Normal manufacturer’s warranty conditions apply.

10. The following are excluded from The Offer:

- a. Any item not listed under Participating Products (Appendix A).
- b. Any factory seconds or items purchased from an auction house.
- c. Display models.
- d. Purchases from any store or website that is not an authorised Smeg retailer.
- e. Clearance items or items purchased from www.shop.smeg.com.au.

11. The Offer is not transferable, exchangeable, or redeemable for cash.

12. To be eligible, claimants must:

- a. be an Australian resident currently living in Australia with an Australian residential and postal address;
- b. not purchase outside of the Smeg Portal; this includes employee, family member or friend of an employee;
- c. be the end user of the Participating Products, meaning the claimant must purchase the Participating Product for their own use and not for commercial purposes, re-sale, re-supply, rental, hire purchase or any other indirect use;
- d. not claim as part of a multi-residential project, new homes development sale, or any purchase on a commercial invoice at commercial pricing;
- e. have paid a 30% deposit to secure the order;
- f. make the purchase during the Promotional Period.

13. The following are excluded:

- a. Products not listed in Appendix A
- b. Complementary products or accessories
- c. Small appliances
- d. Professional ranges
- e. Factory seconds or refurbished items
- f. Auction purchases
- g. Display models
- h. Purchases from non-authorised Smeg retailers
- i. Clearance items or items purchased from www.shop.smeg.com.au

14. The Promoter's decision is final, and no correspondence will be entered into in relation to any such decision.

15. To the extent permitted by law, the Promoter is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers

or providers, computer equipment, software, failure of any email or online registration form to be received by the Promoter on account of technical problems or traffic congestion on the Internet or any website, including any injury or damage to the Claimant's or any other person's computer related to, or resulting from, participation or downloading any materials in connection with the Offer.

16. If a Participating Product is returned for a refund, exchange, or purchase is not finalised, the Offer is disqualified for the product in question and the claimant will not be refunded that portion of the return price.
17. Any costs associated with this Promotion are the claimant's responsibility. All other ancillary costs including but not limited to insurance, taxes (excluding GST) and all other expenses are the responsibility of the Claimant. The Promoter makes no guarantee of the availability of its web services and cannot be held responsible for any interruption of service that may interfere with a claimant's ability to participate in this Promotion. Any costs associated with participation are the claimant's responsibility, including but not limited to insurance, taxes (excluding GST), and related expenses.

Nothing in this agreement excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other implied warranties under the Australian Securities and Investment Commission Act 2001 (Cth) or similar consumer protection laws in the States and Territories of Australia.  - b. in the case of services, the supplying of services again, or the payment of the cost of having the services supplied again.

The Promoter collects PI to conduct the Offer, and may for this purpose, disclose PI to third parties, including but not limited to agents, contractors and service providers and to any Government authorities and agencies.
