Terms and conditions

1. Information on how to claim the bonus Digital Visa Gift Cards form part of these conditions.
2. The promotion runs from the **16th March – 29th March 2026**.
3. Offer is open to individuals who purchase eligible products within specified categories by participating brands.

Specified categories: Ovens, Freestanding Cookers, Cooktops, Ranges, Dishwashers, BBQs, Wine Cabinets, Fridges, Freezers, Sinks, Taps, Washing Machines, Dryers and WashTowers. Excludes clearance lines.

Invoiced and fully paid purchases - A fully paid invoice must be supplied at point of redemption.

| \$4,000-\$4,999 | \$400 |
| \$5,000+ | \$500 |
