

Terms and conditions:

BONUS BBQ Lid

This page contains information on how to redeem Artusi promotional offers and forms a part of these terms and conditions. Participation in this promotion is deemed acceptance of these Terms & Conditions.

Offer is not to be used in conjunction with any other offer. Delivery will be made only within Australia only.

The promotion is valid for Artusi branded products only, purchased from an authorised Artusi dealer during the promotional period.

This offer applies to eligible private retail buyers of eligible, new Artusi built in BBQs during the promotional period. The offer strictly excludes; display stock, factory second & T2 stock, carton damaged, project and commercial sales.

Promotional offer:

Purchase an eligible Artusi Built In BBQ from a participating retailer between 1st May & 30th June 2026 and be eligible to receive a bonus matching BBQ Lid worth upto \$2,349 RRP.

Eligible Customer's must purchase an Artusi Built In BBQ during the following Promotion Period. Who can enter

How to enter

- c) Select applicable eligible lid model for BBQ model purchased – no other BBQ lid can be selected other than the corresponding lid to the BBQ model purchased. Refer to eligible models above for more information.

You can provide us with your proof of purchase by either scanning or taking a photo of your proof of purchase and uploading with your claim form:

- 1) Scanning - scan proof of purchase and save as a PDF
- 2) Photo - take a photo of your proof of purchase from your smartphone and make sure it is in focus and legible.

Redemption form should only be completed via an on-line form on Artusi.com.au in full by the purchaser only, The form can be emailed to the customer should you not be able to complete this on-line form. Please ensure you retain your original proof of purchase. Failure to produce the proof of purchase when requested may, in the absolute discretion of the Promoter, result in the invalidation of an entry and forfeiture of any right to the prize.
